

TeamViewer's International Women's Day Campaign Terms and Conditions

1 Campaign

- 1.1 To celebrate the International Women's Day, TeamViewer Germany GmbH, Bahnhofsplatz 2, 73033 Goeppingen, Germany ("**TeamViewer**") is offering fifty (50) free-of-charge TeamViewer licenses for Remote Access, Business and Premium for one year ("**License**") to support female-led start-ups and small businesses with this campaign in March 2025 ("**Campaign**").
- 1.2 The Campaign is open to businesses with a Chief Executive Officer (CEO) who is a woman or self-identifies as a woman or with a female co-founder. The businesses must have more than five and no more than 30 employees. Businesses must be younger than or ten (10) years. Only businesses with their registered offices in the United States, the United Kingdom and Germany are eligible to participate (hereinafter all together "Participant").
- 1.3 Current customers of TeamViewer are excluded from the Campaign.
- 1.4 In order to enter the Campaign, Participant must fill out a form on the Campaign website and provide the required details for eligibility verification and when receiving a free-of-charge License (i) Participant agrees to use it in accordance with TeamViewer's End-User License Agreement and Data Processing Agreement (link) and (ii) participates in a customer story with TeamViewer and share how they use the License in their company.
- 1.5 The Campaign closes on **March 31, 2025**, at 11:59 pm GMT (the "**Closing Date**") and any entries received after the Closing Date will not be entered into the Campaign. From all valid entries received on or before the Closing Date, Participants who fulfill the entry criteria will be selected at random for one License. Such recipients will be informed as soon as reasonably practicable following the Closing Date.
- 1.6 By entering the Campaign Participant agrees to be bound by these terms and conditions ("Conditions") and confirms that all information submitted is true, accurate and complete. TeamViewer reserves the right to verify the eligibility of any and all Participants and may, in its sole discretion, disqualify any Participant that fails to satisfy the eligibility requirements. Participant shall at all times act in good faith towards TeamViewer and the Campaign. Receiving a License at the Campaign is contingent upon the satisfaction of all requirements set forth herein.

2 Receiving a TeamViewer License

- 2.1 Participants who fulfill the entry criteria may receive one of the 50 TeamViewer Licenses for one year free of charge. The recipient can choose between TeamViewer Remote Access, Business or Premium. The recipient will be sent a code to order the License at her/his choice in the TeamViewer web shop.
- 2.2 TeamViewer reserves the right to substitute the License with another or a similar nature at any time.



- 2.3 The License is non-transferable, non-exchangeable and there is no cash alternative. For the avoidance of doubt should the recipient be unable to receive or use the license for whatever reason beyond the cause or control of TeamViewer, TeamViewer will not be obligated to re-arrange or substitute the license.
- 2.4 If TeamViewer cannot successfully contact the recipient for a License within a reasonable length of time, or if the recipient is unable or unwilling to accept the License, or if the recipient does not meet the eligibility requirements, subsequent draws will take place until another recipient may be found who is able, willing and eligible to receive a License.

3 Privacy

- 3.1 Personal data will only be processed and passed on to the extent required for this Campaign and permitted by law or to the extent that the Participant or the recipient has consented to the disclosure. If and to the extent that the organizer uses the help of third parties to carry out the Campaign, the contractual relationships are subject to the relevant data protection regulations. Participation in the Campaign without providing the required personal data is not possible.

4 Limitation

- 4.1 TeamViewer is liable according to the statutory provisions if TeamViewer has acted intentionally or grossly negligently. In cases of simple or slight negligence, TeamViewer is liable subject to milder liability standards according to the law (e.g. Care in own affairs, diligentia quam in suis) only:
- 4.1.1 damage resulting from death, injury to health or personal injury; or
- 4.1.2 if this negligence violates an essential contractual obligation (cardinal obligation, an obligation whose fulfilment makes the proper execution of the Campaign possible in the first place and on the observance of which the Participant could rely), whereby the liability is limited to typical damages foreseeable at the time of announcement of these conditions of participation.
- 4.2 The exclusions and limitations of liability in Section 5.1 also apply to damage caused by persons for whom TeamViewer is liable under the statutory provisions. The exclusions and limitations of liability in Section 5.1 shall not apply if TeamViewer has fraudulently concealed a defect or if the Product Liability Act prescribes mandatory liability which cannot be excluded.

5 General

- 5.1 TeamViewer reserves the right to cancel or amend the Campaign or these Conditions without notice when reasonably necessary for the purpose of administering the Campaign.
- 5.2 Participation in the Campaign is subject to the law of the Federal Republic of Germany. This law shall apply to the exclusion of the provisions of the United Nations Convention on Contracts for the Sale of Goods, including its amendments, and to the exclusion of the principles of conflict of laws. The exclusive place of jurisdiction is Stuttgart, Germany. Legal recourse is excluded.
